

# Grand Rapids Area Schools Student School Board Representative Application Form

A student representative provides student views and suggestions for the development of educational policies and programs. The primary goal of the student representative is to give input on issues that affect all students and work together with the school board to promote open communication between the school board and the students of Grand Rapids Area Schools. To expand student voice and to share the duties among a team, up to two students will be recommended to share responsibilities of the role. Student representative on the school board will serve as "ex officio members," meaning they are encouraged to participate in discussions, but may not vote on them. The students will be recognized in board discussion in the same manner as directors. More information can be found in policy 202.1 Student Representative on School Board.

#### **About the Student Representative Role**

**Eligibility:** Any high school student enrolled in Grand Rapids Area Schools and dedicated and committed to being an advocate for school district youth can apply to be a student representative.

**Benefits:** The student representatives will gain a wide array of leadership skills that can strengthen future college applications and/or resumes.

**Term of office:** The student representatives can serve a two-year term beginning in September and continuing through May for each school year.

**Time requirements:** The student representative on the school board will attend all regular school board meetings while school is in session, typically the first and third Mondays of each month from 6:00 p.m. to approximately 8:00 p.m. The exact schedule and other information about the board is available at https://www.isd318.org/domain/27

#### **The Selection Process for Student Representatives**

All applications will be screened for completion by the Superintendent's office. A committee made up of a principal, counselor, school board member and superintendent will review completed applications and interview all eligible candidates. The committee will review applications looking for those that best demonstrate their leadership skills, ability to set and follow through on goals, public speaking experience, dedication to public education, and other relevant experience. Applicants will not receive evaluations on their applications, nor will their application materials be returned. The School Board will vote on up to two recommended candidates to serve as student school board representatives. The student(s) will be advised by the Superintendent, along with an appointed School Board member.

#### **Announcement of Student Representatives**

The students selected to serve on the Grand Rapids Area Schools Board of Education will be notified in the month of May, prior to starting the role in September.

Statement of Understanding: I have read and understand the information about the student representatives and the description of the selection process. If I am selected to the position of student representative, I will perform the responsibilities of the student representative to the best of my ability. I understand that Board of Education meetings are videotaped and I may appear in social media, publications, posters, brochures or newsletters; or district or school websites, radio stations, or TV.
